We have been the cornerstone of legal advocacy for the Confederate/Heritage Community and constitutional sanity since 1996 when 3 attorneys and one layman came together to form the Southern Legal Resource Center. We have been working and advocating tirelessly for Liberty & Heritage since 1998 when my winning a large defamation case enabled me to risk opening an SLRC office full time. We've been at it ever since.

Ever since then we have been castigated and demonized by all the right people including the much bally-hoed Southern Poverty Law Center and the NAACP, as well as Dan Rather and numerous fake-news outlets pretending to be major newspapers.

We have always been a small, no compromise, hard-hitting organization, operating on a shoe string with a small staff and we have the battle scars to prove it. Our battlefields have ranged from state & federal courts and in just about every state of the old Confederacy, and Pennsylvania. We have argued cases before the 3rd, 4th, 5th, 6th & 11th US Courts of Appeal and appealed to the Supremes twice.

Our philosophy has been respect for the Rule of Law and non-violent advocacy in a judicial setting, while instructing our fellow citizens on their rights and how they can vindicate those rights by political & social action. We have always understood the "uphill" nature of our struggle and that for "Confederates" (and now almost all of normal America) all our cases are "political." We define "political" cases as a case where government/Deep State/the Left has a heavy vested interest in the outcome. This generally means that all the regular rules and precedents change and usually in favor of

our opponent. This rule - which the rest of normal America is now learning has been true for us since our beginning. In spite of this judicial hostility, the SLRC and the Confederate Community have won some significant victories. But victory or no we believe we achieve a moral victory by putting our opposition's lies & hypocrisy under oath and on the record.

As long as Judges are not shooting SLRC counsel from behind their bench, we believe we must take advantage of the forum available, fair or not - to push our message of heritage & constitutional sanity. At least Pres Trump & the rest of normal America realize how rotten our court system has become.

Where our litigation efforts has failed over the years is in promoting the social activism that must accompany any lawsuit the system deems "political." That means Heritage groups and our supporters must show up at our court hearing and vigorously abuse social media to spread information to the public about the importance of our efforts.

This is why we launched our Campaign to Declare War on Government Speech. We got a lot of feedback on that article - which I find encouraging.

We are involved with 2 cases on the way to the US Supreme Court this Fall, regarding the tyranny of Government Speech - and we must ALL make noise in every media outlet available to us so that the justices "feel the heat."

The so-called moderates in our society must learn that placating the left on the monument issue is like expecting sharks to leave you alone because you fed them. We must beat up on the moderates in our society, who are facilitating the hateful left by caving to their monument removal demands. Getting the moderates in our society to stand with protecting our heritage can be the difference between peace in our time or NOT. We believe we must continue to try!

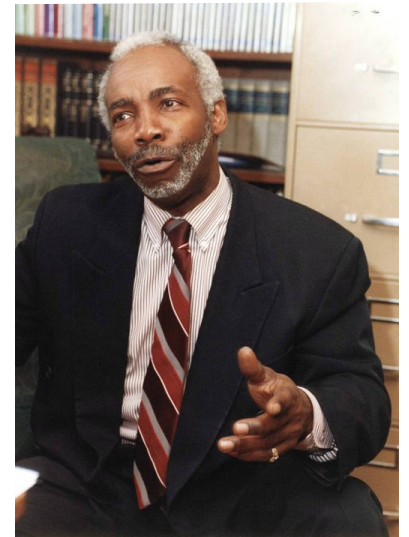
